SB 1136	Wagner	Income tax; international trade facility tax credit.
SB 861	Wagner	Local defined contribution retirement plan.
SB 1481	Wagner	Corporate income tax; Virginia port volume increase tax credit.
SB 1415	Wampler	Methamphetamine; manufacturing, selling, giving, possessing with intent to manufacture, penalties.
SB 1446	Wampler and Colgan	Transportation funding.
