Transportation: \$47.9 Billion Nationwide (6.1% of ARRA Total)

- **Discretionary Grant program** **\$1.5 Billion**
- **Aviation** **\$1.3 Billion**
- **Rail** **\$9.3 Billion**
- **Public Transportation** **\$8.4 Billion**
- **Highways** **\$27.5 Billion**

Recovery Act Public Participation

- **\$466 billion in Virginia projects submitted to Governor's website**
- **\$194 billion in transportation projects submitted or 41.6% of the total value submitted**
- **9,160 total projects submitted**
- **1,800 transportation projects or 19.6% of the total projects submitted**



- **Federal Project Priorities**

 - ✓ **Complete within 3 years (February 17, 2012)**

VERY POOR	0 - 49	Red





Allocation Process

- **Citizen Recommendations**
- **VDOT/DRPT/MPO Recommendations**
- **CTB review and approval of project allocations**
- **TIP amendments through MPOs as necessary**
- **Governor certifies the project list to the USDOT**
- **Obligate funds with FHWA**
- **Execute projects**

Discretionary Grant Program: \$1.5 Billion Nationwide

- **\$1.5 Billion competitive program for projects of national or regional significance**
 - **\$200 Million for TIFIA**
- **Administered by USDOT, rules to be later this month**
- **Eligible projects shall include but not be limited to**
 - **Highways, bridges, eligible under title 23**
 - **Improvements to rural collectors**
 - **Transit under chapter 53 of title 49**
 - **Passenger and freight rail**
 - **Port infrastructure**


Aviation: \$1.3 Billion Nationwide

- **\$200 Million for FAA infrastructure**
- **\$1.1 Billion in grants for noise abatement, soundproofing, runway incursion prevention**
- **Direct FAA funding to Virginia Airports to date**
 - **Dulles runway \$15 Million**
 - **Franklin runway \$2.6 Million**
 - **Mobile rescue trainer \$2.4 Million**

Rail: \$9.3 Billion Nationwide

- **\$8 Billion high speed and intercity rail corridor program**
 - Available until 9/30/12
 - Federal Railroad Administration released strategic plan in mid-April
 - Program focus will be on (i) individual projects and (ii) corridor development
 - By mid-June USDOT to issue interim guidance to applicants
- **\$1.3 Billion for Amtrak capital grants**
- **Sustained advocacy necessary to achieve Virginia's goals**

HIGH-SPEED RAIL CORRIDOR DESIGNATIONS



Public Transportation: \$8.4 Billion Nationwide

- **\$6.9 Billion available through 9/30/2010**
 - \$5.5 Billion for urbanized area formula grants, directly to operators
 - \$700 Million for rural area formula, pass through DRPT
 - \$700 Million for growing states & high density program, funds allocated to states based on formula and are used for urbanized area formula grants and rural area formula grants
 - 50% must be obligated within 180 days, portion not obligated is redistributed to other transit agencies or States
 - Remaining 50% must be obligated within 1 year or is redistributed
- **\$750 Million in rail modernization grants, distributed by formula**
- **\$750 Million in rail new starts and small starts grants, rules to be developed**

Transit: Urbanized Formula Grants

- **Washington Metropolitan Area Transit Authority**
- \$202 million; facilities, buses, equipment
- **Virginia Railway Express**
- \$9.8 million; locomotives
- **Potomac and Rappahannock Transportation Commission**
- \$3.9 million; bus and capital replacement
- **Greater Richmond Transit Company**
- \$13.8 million; transit center, paratransit vehicles
- **Hampton Roads Transit**
- \$24.1 million; facilities buses, equipment

Transit: Small Urban and Rural Grants

- Virginia received \$30.5 million for small urban and rural grants
- In April the Commonwealth Transportation Board (CTB) allocated \$17.3 million in initial grants
 - Small urban: \$13.5 million
 - Rural: \$3.8 million
- DRPT will solicit grant applications for remaining \$13.2 million late Summer/early Fall
- CTB will consider grants this Fall

Highways: \$27.5 Billion Nationwide

- **Virginia will receive \$694.5 Million**
 - Enhancements: 3% - \$20.8 million
 - STP formula: 30% - \$208.4 million
 - Statewide: 67% - \$465.3 million
- **States must obligate at least 50% of discretionary funds within 120 days**
- **Successful states may receive bonus distribution from those states or programs that have not fully obligated federal funds**

ARRA Allocation: Highway Projects

- All cost estimates are subject to change
- At its April meeting the CTB approved \$328 million in initial paving, bridge, BRAC, rail and locally-committed projects
- Five large urban metropolitan planning organizations receive \$118 million directly – project review underway
- Approximately \$250 million in ARRA funds remaining for allocation
- Final recommendations for majority of remaining funds are highlighted in orange

Mandatory Enhancement Projects: \$20.8 Million

- **Timeline requires a small number of projects**
- **Major trail projects especially those with tourism or economic development potential:**
 - **Virginia Capital Trail** **\$8.1 million**
 - **Dismal Swamp Canal Trail** **\$1.3 million**
 - **High Bridge Trail** **\$2.0 million**
 - **Roanoke River Greenway** **\$2.0 million**
 - **Tobacco Heritage Trail** **\$6.0 million**
 - **Valley Pike Trail** **\$0.9 million**
 - **USMC Heritage Trail** **\$0.5 million**

BRAC Projects: \$96 Million

- **Fort Lee (Richmond) – 7,800 BRAC Jobs**
 - **Route 36 Corridor – Prince George County and City of Hopewell**
 - **\$11.4 million**
- **Fort Belvoir (NoVA) – 11,900 BRAC Jobs**
 - **Fairfax County Parkway Phase III & IV – Fairfax County**
 - **\$60.1 million**
- **Fort Eustis (Hampton Roads) – 1,700 BRAC Jobs**
 - **Fort Eustis Blvd – York County and City of Newport News**
 - **\$24.5 million**

Structurally Deficient and Functionally Obsolete Bridges: \$116.1 Million

- 119 small structurally deficient bridges to be repaired through 7 design build contracts - \$66.1 million
- Robertson Bridge (Danville) - \$28.9 million
- Route 61 Narrows Bridge (Narrows) - \$15.7 million
- Route 630/CSX Bridge (Stafford) - \$5.4 million

Deficient Pavements: \$114.6 Million

- 430+ lane miles of interstate and primary highway paving or overlay
- Pavement index of 53 or less for most of the segments
- No right-of-way required and environmental documentation complete
- \$110.9 Million in estimated contract value
- CTB approved additional pavement projects to allow additional projects to be advanced if initial projects come in under bid
- **Mercury Blvd. Paving (Hampton) - \$3.6 million**

Highway Construction: \$122.9 Million

- **Princess Anne Road (Virginia Beach) - \$16.7 million**
- **Port Republic Road (Harrisonburg) - \$22.1 million**
- **Fair Lakes Interchange (Fairfax Co) - \$13.0 million**
- **I-64 Safety Improvements (Alleghany) - \$19.0 million**

Highway Construction: \$122.9 Million

- **I-64 Exit Improvements (Albemarle) - \$2.7 million**
- **Courthouse Road Interchange (Arlington) - \$10.3 million**
- **German School Road (Richmond) - \$3.3 million**
- **Witchduck Road (Virginia Beach) - \$10.6 million**
