# **REPORT OF THE SUBCOMMITTEE ON PUBLIC SAFETY**

**On Senate Bill 800, as Introduced  
(February 6, 2011)**

**Mr. Chairman and Members of the Committee:**

Your subcommittee has reviewed the provisions of Senate Bill 800, the budget bill, as introduced, for the Office of Public Safety.

The past few years have been extremely difficult ones for our state and local agencies that are responsible for protecting public safety. There is no doubt the reductions we have imposed have affected core services, but the agencies have tightened their belts, imposed hiring freezes, cut non-essential spending, and have become leaner and more efficient. These steps are a testament to the outstanding management we are fortunate to have in Virginia, and the loyal state and local employees who have shouldered additional workload in these challenging times.

But make no mistake. We have reduced core services and there are now significant gaps in our budget that we must address. Our report today will address the most critical of these gaps.

We strongly endorse the efforts of the Governor and the Secretary of Public Safety to improve prisoner reentry. Almost all of the inmates in the Department of Corrections are eventually going to be released back into the community, and we support the addition of 45 new probation officers to reduce the chances that these former inmates will commit additional crimes and return to prison. Virginia's three-year recidivism rate is just over 27 percent – one of the lowest rates among those states that measure recidivism in the same manner – but we can do better. This is smart government.

We also recommend additional studies to explore ways to provide lower-cost options for the increasing numbers of geriatric inmates. This is an important priority for this subcommittee.

This year we welcome a new director for the Department of Corrections, Harold Clarke, so this is a good time to take stock of where we are, and what we need to do to maintain a safe, secure, and effective correctional system for the future.

The department has closed eight facilities over the past two years, and is about to close one more. We support the closure of James River Correctional Center as of April 1, but we believe the time has come to begin replacing those beds by phasing-in the new, more efficient facility which has just been completed in Grayson County. The department has maintained over 800 temporary, emergency beds for almost ten years, on top of a very high level of double-bunking in its dormitory units. We should not expect the department to maintain this level of pressure in the system on a permanent basis.

By phasing-in the new facility at Grayson County, we will create 232 new jobs in an area with high unemployment and population loss, in addition to providing a positive impact on the private economy in the region.

We have also seen significant downsizing in the Department of Juvenile Justice, where we welcome the new director, Helivi Holland. This agency has closed two facilities, and we recommend language to consider the closure of one more. We believe the savings from this closure can be redirected to several of our regional or local secure juvenile detention facilities, in order to provide transitional and reentry services on a regional basis – closer to the communities to which the juvenile offenders will be returning.

We recommend the restoration of \$2.5 million for the Virginia Juvenile Community Crime Control Act (VJCCCA), which will still be 14.4 percent below the actual level from fiscal year 2008. This program provides grant allocations to localities for juvenile diversion and crime control programs, which have helped keep down the population growth in our state juvenile facilities. We are getting close to the point that many localities will be shutting down these valuable programs due to lack of funds.

The Department of State Police currently has a vacancy rate of almost 13 percent in sworn positions, so we support the addition of funds in the introduced budget to accelerate the opening of the new Basic Trooper Schools.

The House Bill 599 program of state aid to localities with police departments is very important to us. The total amount of aid for the current fiscal year 2011 is \$178.7 million, but last year we left a huge second year hole in the budget, with the fiscal year 2012 amount dropping to \$160.0 million. Accordingly, we recommend level funding in the second year, so our amendment would restore \$18.7 million in fiscal year 2012. This action will be of great help to our localities in balancing their budgets for next year and maintaining their local police forces.

We are a nation at war, and we are grateful for the continued sacrifices of the men and women in the Virginia National Guard and Air National Guard. We welcome our new Adjutant General, Major General Chip Long, and we support the funds in the budget, as introduced, for maintenance of our National Guard armories.

We also recommend restoring funds to fill seven vacant positions in the Department of Veterans Services, and to provide security and enhance the programs at the new Paul and Phyllis Galanti Education Center at the Virginia War Memorial.

I want to close by recognizing the outstanding work being done in our public safety agencies at both the state and local level to keep Virginians safe. The men and women on the front line in adult and juvenile corrections, law enforcement, fire and emergency services, and in the Virginia National Guard and Air National Guard, and in Veterans Services, stand ready to serve. They deserve our sincere thanks for their dedication to public service.

Mr. Chairman, this completes the report of your subcommittee.

"3. The Board of Corrections may grant approval for the utilization by regional and local jails of temporary housing units, subject to the application of the Board's standards for community custody. Based on the application of these standards, the Board may grant temporary approval, for a period of up to five years, for temporary housing units to be constructed or installed at regional or local jails, subject to the following conditions: (i) the temporary units shall house only outside workforce (outside trustees), work and study release, and weekender inmates; (ii) temporary housing units shall not exceed 20 percent of a facility's rated capacity; (iii) no state reimbursement shall be provided for the capital cost of such temporary units; (iv) such temporary units may not be used to house inmates other than Virginia state- or local-responsible offenders, nor shall federal or other non-Virginia inmates comprise more than ten percent of the jail's overall rated capacity; (v) the Department of Corrections shall conduct at least one inspection of the facility each year; and (vi) the five-year approval period may not be extended without an exemption from the General Assembly. As part of the report provided as of October 1 of each year pursuant to Paragraph B. of this item, the Board of Corrections shall provide information on any temporary facility approvals granted pursuant to this paragraph."

**Explanation:**

(This amendment provides the Board of Corrections with authority to grant approval for regional or local jails to add temporary housing units, subject to certain conditions. This is intended to encourage jails to pursue the least restrictive and least costly construction options that still provide for an appropriate level of security, for Virginia state- or local-responsible offenders.)

2. If the Governor determines that this facility is required to be opened at an earlier date in order to accommodate contractual obligations to house out-of-state inmates, the Director, Department of Accounts is authorized to provide a Treasury Loan to support the necessary start-up operations in an amount sufficient to accommodate the earlier opening date, subject to the approval of the Governor."

(This amendment provides \$12,000,000 from the general fund and 220 positions the second year to open the first two of the four housing units at the new adult medium security correctional facility in Grayson County. A companion amendment to Item 375 provides funds and 12 positions to the Department of Correctional Education to open the school at this new facility. Accordingly, the opening of this facility will provide a total of 232 jobs in Grayson County, not including the indirect impact on private sector employment in the area.)

In no case shall their local match be less than their state share."

"D.1. The Department of Juvenile Justice shall prepare a report on the future of juvenile correctional centers (JCC's) in the Commonwealth. The report shall include: (1) an analysis of JCC utilization rates; (2) an analysis of local and regional secure juvenile detention center utilization rates; (3) a determination of the appropriate number and types of beds, including security levels, necessary to manage the projected state-responsible and local-responsible juvenile population; and (4) an analysis of options for providing regional transitional programs and re-entry services at selected local and regional juvenile secure detention facilities.

2. In preparing this report, the Department shall consult with representatives of the following: (1) the Department of Correctional Education; (2) the Department of Education; (3) the Virginia Council on Juvenile Detention; (4) juvenile court service unit directors; (5) juvenile and domestic relations district court judges; (6) juvenile justice advocacy groups; (7) the Virginia Prisoner and Juvenile Offender Re-entry Council; (8) the Virginia Municipal League; and (9) the Virginia Association of Counties. This consultation shall address the prospect of implementing a plan for: (1) the closing of one state juvenile correctional center and reallocating the cost savings to regional transitional programs and reentry services at selected local and regional juvenile secure detention facilities; and (2) identifying funding to be transferred for the purpose of reinvesting in such programs and services. The report shall detail the feasibility and core components of such a plan and shall include a fiscal analysis of the impact on localities and on the Department of the plan. The fiscal analysis shall address state responsibilities related to transportation, education, medication, assistance to support security services provided directly by the juvenile detention facility, and comprehensive programming provided on a contractual basis by private, for-profit and nonprofit providers, based on evidence based practices.



3. The report shall be provided to the Governor, the Secretary of Public Safety, and the Chairmen of the Senate Finance and House Appropriations Committees on or before October 1, 2011."

(This amendment provides for the development of a plan for closing a state-operated juvenile correctional center and reallocating the cost savings to transitional programs and reentry services in selected regional or local juvenile secure detention facilities in the 2012-14 biennium.)

"The Commonwealth shall construct and operate a wastewater treatment plant at Augusta Correctional Center to provide wastewater treatment for that facility. The plant shall also have sufficient capacity to serve the Town of Craigsville, provided that prior to March 15, 2011 the town does the following: (1) notifies the Department of Corrections in writing that it elects to have its wastewater treated by the department at the department's new plant; (2) deeds to the Commonwealth that land previously deeded by the Commonwealth to the town for the construction of the town's currently existing wastewater treatment plant; and (3) relinquishes and provides for the transfer of the town's current treated wastewater discharge permit from the town to the Department of Corrections by the Department of Environmental Quality. As a further condition of this arrangement between the department and the town, the town shall continue to treat the wastewater from Augusta Correctional Center under its current contract with the department until such time as the department's new wastewater treatment plant is operational. In return the department shall treat the town's wastewater at no cost for the first 36 months after the plant becomes operational and thereafter shall treat the town's wastewater at rates essentially the same, local conditions being considered, as the rates charged other municipalities for which it provides wastewater treatment."

**Explanation:**

(This amendment provides a policy framework for the construction of a new wastewater treatment plant at Augusta Correctional Center, with sufficient capacity to serve the needs of the Town of Craigsville.
