REPORT OF THE SUBCOMMITTEE ON PUBLIC SAFETY
On Senate Bills 29 and 30, as Introduced
(February 16, 2014)

Mr. Chairman and Members of the Committee:

Your subcommittee has reviewed the provisions of Senate Bills 29 and 30, the budget bills, as introduced, for the Office of Public Safety.

Under the provisions of SB 381, the current appropriations and positions for homeland security will move from the Secretary of Veterans Affairs and Homeland Security to the Secretary of Public Safety, consistent with the findings of the 2013 JLARC report on disaster preparedness. The two secretariats will become the Secretary of Veterans and Defense Affairs, and the Secretary of Public Safety and Homeland Security. We support this proposal and recommend the appropriate modifications in the budget.

There has been much discussion of sexual and domestic violence programs this year, and we are recommending a substantial increase in funding through the Departments of Criminal Justice Services and Social Services. Our amendments add \$4.0 million to these programs over the biennium, along with additional general funds and TANF funds in DSS which will be recommended by your Subcommittee on Health and Human Resources. We are also recommending a task force under the leadership of the Office of the Attorney General to determine the best arrangements to administer these programs.

Our report includes funds to implement the new lifetime concealed handgun permits, under the Department of State Police, as authorized in Senate Bill 608. This new statewide approach will result in a much more secure process for issuing concealed handgun permits, and the system is estimated to generate a net increase in general fund revenues (in excess of expenditures) of \$2.7 million over the biennium. We recommend using these additional funds to restore the base budget of the Department of State Police in the second year.

We have included \$788,309 for the required deposit to the Corrections Special Reserve Fund, based on the criminal sentencing bills adopted by the Senate which affect the future need for correctional facility bedspace. We recommend this amount be set aside for debt service in the first year of the biennium for the new correctional facility in Grayson County.

We recommend approval of the plan to convert the Culpeper Juvenile Correctional Center into a women's correctional facility. This plan recognizes the declining population of our secure juvenile facilities, as well as the continuing growth in the number of female inmates in the Department of Corrections.

By closing the Culpeper juvenile facility (even after transferring funds to the Department of Corrections to reopen Culpeper as a women's facility) there is still a net savings of over \$9.6 million (over two years) that we are reallocating to increase community-based placements and treatment of juvenile offenders whenever possible, and reduce our reliance on secure juvenile facilities at the state level. The end result of this process is that our remaining state-operated juvenile facilities (at Beaumont and Bon Air) will house a higher percentage of more serious offenders, and those with more serious mental health needs.

We are pleased to report that the budget as introduced includes new funding for state aid to localities with police departments (the "599" program), consistent with the growth in general fund revenues. This program is based on House Bill 599 of the 1979 General Assembly, which was intended to resolve the battle over annexation and help those central cities that would no longer be able to grow through annexation. We recommend adjusting the distribution so that every jurisdiction is held harmless at the FY 2014 base level, with all of the new money each year to be distributed through the formula. We believe this represents a reasonable accommodation of the interests of those jurisdictions with the fastest population growth, and the central cities which would otherwise lose out under the formula because their population is not growing as fast.

Finally, your subcommittee recommends \$480,000 each year for the Virginia National Guard to acquire radios that are compatible with the STARS Statewide Agency Radio System, using the Master Equipment Lease Program. In the event our National Guard units are called out to assist in an emergency situation, this will enable them to communicate directly with State Police and other first responders.

I want to close by recognizing the outstanding work of our public safety and homeland security agencies at both the state and local level, especially as they have been asked to do more with less in recent years. The men and women in corrections, law enforcement, fire and emergency services, forensic laboratories, ABC, and the Virginia National Guard and Air National Guard, all deserve our sincere thanks for their tireless efforts 24 hours a day, 365 days a year, to keep all of us safe.

Mr. Chairman, this completes the report of your subcommittee.

All localities which use this service shall be required, as a condition of receiving med-flight services, to seek appropriate third party reimbursement for the expenses involved in medical evacuation, to the maximum extent possible."

Explanation:

(This amendment provides \$200,000 the first year from the general fund to Chesterfield County for its use in funding the local paramedics who support the State Police med-flight helicopter operation based in Chesterfield County.)
