Further, it requires that the Department of Medical Assistance Services develop a plan to improve awareness of the Plan First Medicaid family planning program. The only difference in this amendment from the original is that it limits the funding to only be used for the purchase of the LARC device and cannot be used to reimburse providers for the insertion or removal of LARCs. If the Senate chooses to adopt this amendment then amendment 292#2s adopted in SB 30 in the 2018 Regular Session will need to be rejected and this one will replace it.
