Developmental Disability and Intellectual Disability Community Based Services

Who uses the DD Waiver? People six years or older who have developmental disabilities such as autism, cerebral palsy, spina bifida, brain injuries that occur before the age of 22 and epilepsy. Persons who use the DD Waiver cannot have an intellectual disability.

Who uses the ID Waiver? Children under the age of six who are at risk of developmental delay and people of any age who have a diagnosis of intellectual disability.

Efforts to combine the DD and ID Waiver should be led by DMAS as the entity responsible for Medicaid administration.

- DD Waiver offers family caregiver training not available in the ID Waiver.
- ID Waiver offers congregate group home services not available in the DD Waiver.
- DD and ID Waiver wait lists are managed differently.
- People using the DD Waiver tend to use consumer-directed services more than people enrolled in the ID Waiver.
- People using the DD Waiver live in integrated, typical housing.
- People using the ID Waiver often live in congregate group homes.

Medicaid DD and ID case management are organized and provided differently.

Medicaid DD Case Management

- People choose their provider of case management.
- Provided by 22 nonprofit and for profit private organizations.
- Available to people with a goal case management could assist with who are enrolled in Medicaid.
- Must be on the DD Waiver wait list or enrolled in the DD Waiver.
- Medicaid rate is \$175.40 month.

Medicaid ID Case Management

- No consumer choice of provider.
- Provided by CSBs, unless the CSB opts to contract the service to another provider.
- Available to people who have a diagnosis of ID or who are under the age of six and at risk of developmental delay who are enrolled in Medicaid.
- Do not have to be on the ID Waiver wait list or enrolled in the ID or Day Support Waivers.
- Medicaid rate is \$326.50 month.

Medicaid DD and ID case management are similar services. DD case management regulations require one extra service, the provision of benefits counseling.
